Tournament Rules

1. **Mixed Doubles** competition - Sunday, April 14, 2024 at the Orleans Bowling Center.
2. Bowl 4 games on the same pair of lanes (Max. 6 bowlers/pair)
3. Start time: 9:00am. Check in starts at approx. 7:30 am.
- 4.2 Divisions available: Scratch & Handicap
 - a. Teams may enter Handicap, Scratch or Both (Separate Prize fund for each division)
5. **MULTIPLE DOUBLES:** A bowler is allowed to bowl doubles with up to 4 partners at the same time by paying the appropriate entry fees.
6. Youth bowlers **ARE NOT** permitted to bowl this event.
7. **Current PBA/PWBA national tour players and players who have won a national USBC or PBA/PWBA title in the past 5 years are excluded from this event.**
8. Only one PBA/PWBA player per team.
9. Entry Fee is \$130 per team (\$65 per bowler). Fee breakdown: Prize fund - \$77; Lineage - \$36; Expenses - \$17.
10. 1 in 6 teams will cash per division.
11. **Team Handicap is 90% of the difference between the team average and 440.**
12. **Maximum individual score per game is 300 with or without handicap.**
13. Teams **MUST** consist of 1 male and 1 female adult bowler.
14. **May cash only once with the same partner per division.**
15. Minimum individual entering average: 140
16. **NO TEAM CAP.**
17. **Optional Singles:** 4 division: Men's Scratch; Women's Scratch; Hdcp 175 & ↑; Hdcp 174 & ↓
18. Singles entry fee: \$40. Fee breakdown: Prize Fund - \$36; Expenses - \$4
19. 1 in 6 bowlers will cash per division.
20. Singles handicap is 90% of the difference between the bowler's avg. and 220.
21. Bowlers who average less than 220 may enter both handicap and scratch divisions.
22. **Entering Average:** Highest USBC standard composite average from the past 2 seasons (2021-22 / 2022-23 will be used).
 - a. If a bowler does not have a current book average, the current league average of 21 games or more may be used.
 - b. If no current book or league average, the bowler must use the scratch average: Men - 220; Women - 200.
23. If your current league average is more than 10 pins over your current book average, the current league average will be used.
24. **It is each bowler's responsibility to report the correct average. Failure to report the correct average will result in disqualification.**
25. It is the bowler's responsibility to report any re-rates within the past 5 years.
26. Tournament director reserves the right to re-rate players at any time.
27. **Prize funds will be paid in cash shortly after competition concludes.**
28. **Pre-registration deadline: Wednesday, April 10, 2024.**
29. **NO VENMO, CASHAPP OR PAYPAL payments accepted after April 10, 2024.**

 - b. **CASH ONLY on site.**
30. Brackets; High Game Pots; Eliminator Pots; 300 jackpot; Men's & Women's Doubles Pots; Mystery Score available.
 - a. Only scratch 300 is eligible to win the 300 jackpot. If no 300 is rolled in this event, the jackpot will be carried over to the next event.
 - b. If multiple 300's are rolled during the event, jackpot will be split equally for each 300 game rolled.
31. This is NOT a USBC sanctioned event. Decisions made by tournament officials are final, binding and not appealable. Any disputes not covered herein will be resolved according to USBC rules.
32. In the event of a malfunction, tournament officials and bowling center staff will make a reasonable accommodation to resolve the issue.
