## 2024 Spokane County USBC Youth Championship Tournament Rules

- 1) This tournament consists of a doubles event and a singles event.
- 2) At least one in three entries in each classification will receive awards. All award fees will be returned 100%. Scholarships will be sent to SMART Account #9827.
- 3) Champions in each event will be recognized for their achievements at the Association Banquet.
- 4) Doubles handicap will be 90% of the difference between the team average and 440 and Singles handicap will be 90% of the difference between the individual's average and 220. (All fractions will be dropped).
- 5) CLASSIFICATIONS ARE AS FOLLOWS:

<b>DOUBLES</b>	<b>SINGLES</b>
a. 301 and over	151 and over
b. 300 and under	150 and under
- 6) Entry fees: \$40 for doubles and \$20 for singles. (\$8.50 for prize fees, \$10.00 for bowling and \$1.50 for expenses per bowler per event.)
- 7) All Youth members holding a current USBC membership card are eligible to enter. **USBC RULES WILL GOVERN THIS CERTIFIED TOURNAMENT. Non USBC Youth participants must pay \$4 for the Standard Membership prior to bowling (Rule 300c)**
- 8) All entries must be eligible under USBC Youth Rule 400. An individual may only cash once in the singles event as per USBC Rule 315c.
- 9) Use your highest certified average, based on a minimum of 12 games, for the 2022-23 season or  
If no 2022-23 season average, use your January 1, 2024 average, based on a minimum of 12, games or  
If no 2022-23 average or January 1 2024 average, use highest average, based on a minimum of 12, games for the previous seasons or  
If no verified average, bowlers under the age of 14 (on August 1, 2022) will use an assigned average of 120 and those 14 and older will use an assigned average of 159.  
**RULE 319a IS WAIVED.**
- 10) **Any bowler who has only a certified average from a non-standard league will have their average rerated based on the USBC Challenge/Sport Conversion chart.**
- 11) The Tournament Manager has the right to re-rate bowlers prior to bowling. Their entry fees will be returned if the bowler does not accept the re-rated average.
- 12) Poor sportsmanship will not be tolerated. Undue displays of temper and the disturbing of other bowlers will not be allowed. Poor conduct or abuse of bowling center equipment may result in disqualification by the Tournament Director.
- 13) All protests or appeals must be submitted in writing to the Tournament Manager within 72 hours of the date bowled as per USBC Rule 329.
- 14) **All bowlers MUST be checked in at least one-half hour prior to squad times, and averages verified by coaches.**
- 15) Dress attire must be neat, clean and proper fitting. Collared shirts and slacks, walking shorts, capris, or skorts are suggested. **No hats, denim with holes, spandex, leggings, or sweats will be allowed.** Youth participants will not wear apparel or use bowling equipment depicting alcohol, gambling, an illegal substance or use inappropriate language/gestures during competition (USBC Rule 301b). Tournament Director must approve any/all exceptions. Tournament Director's decision is final.
- 16) If the tournament, or squads in the tournament, is cancelled due to unforeseen circumstances, the entry fees for bowlers scheduled in the cancelled squad(s) will be refunded.
