## TOURNAMENT RULES

1. This tournament shall be sanctioned by USBC.  
Rules 319.3.2, 319c and 319d DO NOT APPLY
2. All entrants must be members of USBC, and Aerie/Auxiliary members in good standing.  
Teams shall consist of 3 Men or Women or mix of either Men & Women. You will be bowling 4 games.
3. Handicap will be based on individual averages 90% of 220 scratch per bowler for Singles, 90% of 660 scratch for 3-Person team using USBC handicap chart.
4. Highest sanctioned standard league final average (21 or more games) from the 1) 2017-2018 season shall be used or a bowler with no final average from the 2017-2018, 2) shall use 21 game average from the current year as of January 1, 2019 verified by league standing sheet or 3) All others will bowl scratch.
5. Bowlers are responsible for verifying their own average, whether submitted by the bowler, team captain or others. If the submitted average is lower than actual average and results in higher handicap, the bowlers score is disqualified. If the submitted average is higher than required, prize winnings will be based on the submitted average. (USBC Rule 319A(3). Average corrections must be made before the end of the first game of a series.
6. Multiple entries are allowed if 1 or more team members are changed and declared 30 minutes prior to bowling. Members may participate a maximum of 3 times in team and 2 times in Singles. You can only cash once in Singles. (USBC Rule 115).
7. All prize fees will be returned 100% on a ratio of at least one prize for each 5 entries, or a major fraction thereof. Prizes will be distributed within 30 days of the close of the tournament (USBC Rule 309(<1)). A prize list will be mailed to each team captain.
8. Substitutes will be allowed and must take the place vacated by the absent member and may be made at the tournament director's desk not later than 30 minutes prior to the start of squad time. Substitutes will not be furnished by the tournament office.
9. Team captains are to have their members present one-half hour before scheduled time to bowl. Captains must present USBC as well as Aerie/Auxiliary cards for each member.
10. Entries will be scheduled according to request and in the order received. After an entry has been received, and the dates assigned by tournament management are not refused before preparation of the schedule, the entry fee cannot be refunded. (USBC Rule 314).
11. All entries close as of the start of last squad. April 14th, 2019
12. USBC sanctioned tournament rules apply if not covered in the rules above.
