## DOUBLES HANDICAP TOURNAMENT <br> March 2nd \& 3rd, 2024 at Oak Bowl USBC CERTIFIED

This tournament will be conducted under the rules and regulations of the USBC. Entry into this tournament is open to all current adult members of USBC. Non-members may purchase a membership by paying a fee of $\$ 25.00$ ( $\$ 15.00$ National; $\$ 2.00$ State; $\$ 8.00$ Local) prior to bowling in the tournament. Subject to lane availability, entries for each squad will close 15 minutes before the start of each squad and based on lane availability.

AVERAGES: Average used for purpose of handicap will be as follows:

1) Will be based on the highest 2022-2023 composite league average of 21 games or more.
2) If no 2022-2023 composite average, the highest 2023-2024 league average of 21 games or more may be used.
3) It is the responsibility of the individual bowler to provide the appropriate standing sheet from the league and/or leagues to verify the current average. We require the actual standing sheet for final audit of scores.
4) Bowlers without an acceptable 21 game average must bowl scratch.

Bowlers are responsible for the accuracy of their own average, whether submitted by the bowler, partner or others. All averages will be verified and may be re-rated in accordance with all USBC 319 rules. Correction of the average may occur before the end of the entrant's first game. Failure to use an adjusted average in accordance with the 319 rules is cause for forfeiture of entry fees and prize winnings.

HANDICAP: Will be based on $90 \%$ of 230 for men and women.
DOUBLES MAY CONSIST OF THE FOLLOWING COMBINATIONS: 2 MEN; 2 WOMEN; or 1 MAN AND 1 WOMAN

MULTIPLE PARTICIPATION: Entrants may bowl twice with the same partner, but cash only once. Entrants may cash more than once, if done with another partner.
