This tournament will be conducted under the rules and regulations of the USBC. Entry into this tournament is open to all current adult members of USBC. Non-members may purchase a membership by paying a fee of $\$ 25.00$ ( $\mathbf{\$ 1 5 . 0 0}$ National; $\$ 2.00$ State; $\$ 8.00$ Local) prior to bowling in the tournament. Subject to lane availability, entries for each squad will close 30 minutes before the start of each squad and based on lane availability.

EVENTS: Handicapped 4 person team, doubles, and singles; optional handicapped all events.
AVERAGES: Average used for purpose of handicap will be as follows:

1) Will be based on the bowlers 2022-2023 composite average of all USBC leagues, including leagues with less than 21 games bowled.
2) If no previous season average, the bowlers composite average from all current USBC leagues must be used, provided that the total number of games bowled from all leagues combined equals 21 games or more.
3) Rule $319 a 2$ will be waived.
4) Bowlers without an acceptable 21 game average must bowl scratch.

Bowlers are responsible for verifying his/her own average. Average corrections can be made up until the end of the bowler's first game of a series. Additional time may be granted by the tournament manager.

HANDICAP: Will be based on $90 \%$ of 230 for singles.

## MULTIPLE PARTICIPATION:

Team Event: May bowl more than once, provided that a minimum of (2) team members are changed. Doubles: May bowl twice with the same partner, but cash only once. May cash more than once, if done with another partner.
Singles: Entrants may bowl as many times as they wish, but cash only once.

AWARDS: Estimated prizes shall be at least 1:4 entries. ALL PRIZE MONEY COLLECTED WILL BE RETURNED 100\% TO PARTICIPANTS IN THE TOURNAMENT. In the event of a tie, co-champions will be declared and no roll off will occur.
