NDUSBCY TOURNAMENT RULES AND REGULATIONS

- ALL USBC RULES ARE APPLICABLE.**
- ELIGIBILITY** – Must be an active member of the Northern Delaware USBC Youth Bowling Association by 10/20/19. Athletes sanctioned after 10/20/19 are not eligible to participate in this tournament.
- AVERAGE** – A bowler's average for use in the tournament is determined as follows:
 - Highest 2018-2019 Winter league sanctioned average;
 - If the bowler does not have a 2018-2019 Winter league sanctioned average, but participated in a 2019 Summer NDUSBCA Sanctioned league and had 21 or more games in the league, the bowler's final average for the 2019 Summer sanctioned average will be used (Average sheet must be provided and attached to this entry);
 - If the bowler does not have a sanctioned average as stated in either A or B above, then the bowler will use the current year average if there has been at least 9 games bowled through and including 10/20/2019 (Average sheet must be provided prior to start of competition);
 - If none of the sanctioned average qualifications as stated above in A, B, or C are met, the bowler **MUST** bowl scratch.
- AVERAGE ADJUSTMENT rule #319 is waived.**
- HANDICAP** will be 90% of 225 for each bowler. No negative handicap.
- AWARDS/SCHOLARSHIPS** – will be awarded separately for Singles, Doubles and Team Events. All Awards/Scholarships will be awarded on handicap basis at a ratio of at least one for every 5 entries. The number of tournament entries in each division will determine amount of scholarships. If there is a minimum of 10 entries per division per event there will be a guaranteed award

of \$100 scholarship to the winner(s). All award/scholarship money will be returned 100% to the bowlers. All scholarship funds will be held and managed by SMART SF, c/o USBC, 621 Six Flags Dr, Arlington, TX 76011. A bowler with the highest pins over average scratch for a 3-game series will win a free entry into the DE State USBC Youth Tournament.

7. **OPTIONAL SCRATCH ALL EVENTS** – Open to everyone who pays the additional \$5 entry fee and bowls in the singles, doubles and team events. Award fees will be returned 100% and at a ratio of at least one (1) scholarship for every twenty (20) entries. There will be only one scratch division. Entry fee must be received by 10/26/19.
8. **HANDICAP ALL EVENTS** – will be 90% of 225 per event. NO NEGATIVE HANDICAP. To be eligible for the Handicap All Events Award, the athlete must bowl singles, doubles & team events. Highest score with handicap in each division will be awarded one paid entry of choice into the 2019-20 DE State USBC Youth Tournament. (Entries are not transferable.)
9. **TIES:** In the event of any ties, prizes for the positions affected will be equally divided.
10. **LINE-UP** cannot be changed. If you are not present to bowl, a “0” will be given for each frame missed. Once a substitute has bowled the first scored ball, the substitution stands for ALL 3 games. Bowlers must get permission from a scorekeeper or official to leave the bowling enclosure.
11. **MULTIPLE ENTRIES** are allowed in the doubles event provided entries are received by the tournament closing date of 10/27/19, and no more than 1 of the 2 bowlers on the doubles team are the same. Re-entries will be accepted up to 30 minutes prior to the start of the squad provided that there is lane availability and at the discretion of the Tournament Director. (See rule #16 below.) The scores bowled in the first double entry will be used towards All-Events.
12. **NO PLAYING VIDEO / HANDHELD GAMES during competition. E-Readers, MP3 Players or iPods will be allowed only in music or reading mode. They will not be allowed on the approaches while the bowler is bowling. No cell phones will be allowed during competition. If you need to make a call or receive a call, please contact the tournament director as soon as possible. This will only be allowed for an emergency. The tournament director will determine if it is an emergency or not. Failure to notify the tournament director could result in disqualification.**
13. **DRESS CODE:** Athletes must wear shirts that cover the entire midriff area and have a collar similar to golf or polo shirts. (Mock turtlenecks with a sport logo (such as Nike®) or tee-shirts from a youth bowling program or USBC are acceptable.)
 - A. Shorts and Skirts are allowed but must be no shorter than 2 inches above the knee.
 - B. Advertisements on apparel or bowling equipment depicting alcohol, tobacco, illegal substance, and gambling or inappropriate language/gestures during tournament competition will not be allowed.
 - C. Pants must be worn at the waist or held there with a belt. Torn or cut jeans will not be allowed.
 - D. No hats of any kind are permitted. (Unless for religious reasons.)
 - E. All clothing apparel must be the correct clothing size. (Example: if you wear a medium size shirt normally then do not wear an XXL shirt.) Bowlers will be required to change if tournament officials deem attire inappropriate. Tournament official’s decision will be final.
14. **50-50 TICKETS** will be sold to benefit the Award/Scholarship Fund.
15. **PROTESTS/APPEALS** – All decisions of the tournament manager are final unless a protest/appeal is filed within 72 hours in accordance with Rule #329.
16. **ENTRIES WILL NOT BE ACCEPTED WITHOUT AVERAGE SHEETS AND PAYMENT.** All entries must be rec’d by 10/21/19. Late entries will be accepted up to 30 minutes prior to the start of the squad provided that there is lane availability and at the discretion of the Tournament Director.
