- 1) **USBC Sanctioned Tournament**, all bowlers must have a valid USBC membership card and all USBC Rules will be enforced including 319 Rule.
- 2) Teams shall consist of 3 Women Bowlers
- 3) Handicap will be 90% of 230. **No minus**. Individual handicap
- 4) Team line up will be:
  - A) 1<sup>st</sup> Position Lowest Average on the Team
  - B) 2<sup>nd</sup> Position 2<sup>nd</sup> Highest Average on the Team
  - C) 3<sup>rd</sup> Position Highest Average on the Team
- 5) Points:
  - A) 1 point for Individual win
  - B) 2 points for a Team win
  - C) 5 total possible points per Game
- 6) In the case of a tie, total pins with handicap will break the tie
- 7) We'll be using your high book average from 2018-2019 season. If **no book average**, you may provide a current standing sheet closest to the date of the tournament reflecting 21 games or more or a 230 average will be used. Any sport/challenge league or sport/challenge shot average will be adjusted according to the USBC rulebook.
- 8) Check In will be at 11am, Practice will begin at 11:40am and start at 12pm. This will allow you time to practice on all lanes in the house. This is a Swiss Style Tournament so each game is a position round. All payments must be submitted prior to starting the tournament.
- 9) Any bowler arriving late for a game will receive a zero in that frame.
- 10) No team, may have more than 1 member of the Professional Bowlers Association
- 11) It is each teams responsibility to mark points won and pin count correctly. If not marked correctly, points will not be awarded and no rematches. 1 Point for Individual Win / 2 Points for Team Win
- 12) Entry Fee Breakdown: \$35 Lineage and Expenses / \$30 Prize Fund
- 13) Tournament Director holds the right to re-rate any bowlers average. Should bowler not agree with the re-rated average, his/her entry fee will be refunded. Tournament Director reserves the right to make all tournament related decisions.
- 14) No Show = No Refund. There will be no refunds issued for dropping out within 10 days of the tournament.
