TOURNAMENT RULES

- 1. Bowl 3 games. TOAL HANDICAP SCORES WILL BE USED FOR ALL DIVISIONS BELOW.
- 2. Divisions:
 - (a) Singles (Main)
 - (b) Blind Draw Doubles (OPTIONAL)
 - (c) Women Only (OPTIONAL)

***NOTE: There will be separate payouts for each division as well as the optional brackets – five total.

- 3. This is a HANDICAP TOURNAMENT. Handicap will be based on 90% of 220 for ALL bowlers.
- 4. Bowlers average will be based on USBC or Putters & Gutters (P&G) book averages from Jan 1, 2024 to PRESENT.) If OUTSIDE of Marble Falls P&G, it is the bowler's responsibility to provide a correct and current average. If no verifiable average, bowler will use a 220 scratch average for all divisions and brackets entered into.
- 5. No tap means that a strike will be given to the bowler when a 9-count is bowled on the first ball.
- 6. Ties will be broken by whoever has the most natural strikes (if still tied, individuals will split prize equally.)
- 7. Payouts will be distributed at the end of the tournament.
- 8. Prizes will be distributed at a ratio of 1 in 7 (based on number of entrants.)
- 9. This tournament is not sanctioned; however, USBC rules apply for this tournament.
- 10. Tournament Expenses:

Entry Fee: \$35.00 (\$15.00 lineage, \$16.00 prize fund, \$4.00 admin fee):

Pay Ratio 1:7 (1st Place: 50%, 2nd Place: 21%, 3rd Place: 14%, 4th Place: 7%, 5th Place: 3%, 6th Place: 3%, and 7th Place: 2%)

- a. Optional Blind Draw Doubles \$10 entry (paid back as 1 in 4 up to a MAX of 3 plus ties.) Payout will be $1^{st} 55\% | 2^{nd} 30\% | 3^{rd} 15\%$ using 3-game total score, split equally.
- b. Optional Women's Only \$10 entry (paid back as 1 in 4 up to a MAX of 3 plus ties.) Payout will be $1^{st} 55\% | 2^{nd} 30\% | 3^{rd} 15\%$ using 3-game total score.

****NOTE: Optional bracket entries are not required to enter the tournament. Two divisions only: Men's and Women's. \$5 per bracket with a max of 3 entries per bowler. Payout is 60% for first place and 40% second place.

THE TOURNAMENT IS LIMITED TO THE FIRST 50 ENTRANTS WITH AN ALTERNATE/WAITING LIST.
