## **GOLDSBORO USBC**

### **Open Masters Tournament Rules**

1. Every entrant must be a sanctioned member of the USBC. This Tournament is OPEN to bowlers outside of this association.
2. All USBC rules and regulations will govern this tournament.
3. All games will be bowled using their scratch score.
4. Entrants shall use the highest USBC sanctioned league average as a regular or substitute in the following order:
5. Entries close for all check or money order payments on May 15th, 2021.
6. Entry fee per bowler will be \$70.00. All entries must be accompanied by full entry fees and must be paid by check, money order, cashier check, or cash (Make sure you get a receipt if paying with cash). Money orders and cashier checks must be made payable to the Goldsboro United States Bowling Congress or Goldsboro USBC before deadline.
7. The line-up will vary based on lane availability and number of entrants.
8. Check-in will from 1:00 pm – 1:45 pm. No late arrivals will be permitted once tournament play has started.
9. Any protest affecting eligibility or general playing rules must be confirmed in writing to the tournament chairperson before the tournament payments are made. Errors in scoring must be reported to the chairperson within 48 hours.
10. When a tie exists for any first place in any event, co-champions will be declared. First and second place money will be combined and divided equally. In the event of a tie for any other position standings, the prize money will be combined and divided equally among the tied position winners.
11. All winners will receive awards (in the form of cash or SMART Account) according to the prize list posted and will be presented at the end of tournament play on Sunday, May 23rd, 2021.
12. **The attendance of children is discouraged. Under no circumstances will children be allowed to run around the lanes during tournament play.**
13. Camcorders and/or Camera's will be allowed if there is no flash or extra lighting involved. Individuals using these devices MUST stay out of the pits and out of the way of bowlers.
14. The board of directors of the Goldsboro United States Bowling Congress, Inc. shall have the power to hear and act on all protests arising from and under construction of the rules of this Goldsboro USBC tournament.
